# **Department 21 Sections 1-9 - Home Made Wines**

## Rules

- IMPORTANT With exception to rule 19 for the transport, entry and tasting of wine and beer under the Alcohol permit. The GENERAL RULES AND REGULATIONS apply; Entry Form deadline, delivery, judging and release dates/times, pass, and entry fee – see ENTRY PROCESS/ENTRY FORM/FEE TABLE.
- 2. Wines and beers entered for competition in this Department must be amateur wine or beer, home produced in accordance with the Code of Federal Regulations, Title 27, Chapter II, Part 24 (Wine) or Part 25 (Beer).
- **3**. All wine or non grain mead entries must be in a 750 ml bottle, sealed with cork or screw cap. Corks in screw top type bottles will not be accepted.
- 4. All beer, cider or grain mead entries must be in a 12-32 Oz bottle, sealed with screw or crimp cap.
- 5. An entry will be one bottle.
- 6. A): Entry Number will be added by Fair Staff. When entry form and bottle are paired.B): All bottles entered in the wine competition must have an information label as follows (type or print): year of fermentation; name(s) of grape(s), fruit(s), honey, or other fermentable. Vineyard or Wine Maker's labels are encouraged as they serve to accentuate display of the entries. The label does not need to be removed but it nor the information on it will not be accepted as a substitute for the required information label. A separate label which meets the order and standards in this statement must be applied to the bottle.
- 7. Wines produced and bottled may be from any years' grapes, grape concentrate, fruit, fruit juice, honey, or fermentables other than Grains. Grain fermentations will not be accepted as wine but may qualify as Beer or Cider in classes 6-9
- 8. Wine will be judged on 1; Appearance, 2; Aroma and bouquet, 3; Taste and Texture, 4; Aftertaste, 5; Overall Impression. During which time, all labels will be concealed from the judges.
- **9**. Any category that does not have 5 total entries will be combined to another category at Judge's discretion.
